## Planning and Movement in Banbury

There are not many discussions with friends or acquaintances that do not, eventually, get around to bemoaning the problem of 'getting about' Banbury. Movement is essential for the economic health and vitality of our community and for the well-being of our members.

For this reason the Society is represented at the quarterly Banbury Traffic Advisory Committee and keeps a close watch on development proposals and infrastructure 'improvements' intended by the Highway Authority (Oxfordshire CC).

The Society has also put forward ideas to improve the bus / rail interchange at the railway station in the light of the increasing use of rail commuting that is taking place.

We are given to understand that the Local Transport Plan 4 (LIP4) is to be reviewed. Many, if not all, the difficulties arising from traffic movement arise, in our opinion, from the limited east-west routes available across the barrier formed by the railway, the river and the canal. The only routes available are Middleton Road and Hennef Way. The former passes through

a well developed residential area and is therefore unsuitable for volumes of traffic above that generated by the resident population and the latter is the main access to the M40 and destinations to the east. It currently carries approximately twice its designed volume of traffic which causes one of the two 'Air Quality Action Zones' in Banbury.

Planning proposals such as the expansion of Tarmac's aggregate unloading depot in Water Works Lane (off Hennef Way) and the predicted additional 160 HGV movements each way per day this



will generate, mainly for HS2 needs, adds focus on the capacity of Hennef Way and the effects on the health and well-being of the nearby residents.

The role of Hennef Way is further brought to the fore by the fresh proposals for the Banbury 15 (M40) site currently before the District Council.

It is understood the OCC has

been granted funds by the Oxfordshire Growth Board to investigate the option of creating another north-facing access./egress to the M40 from Southam Road at the Hardwick Hill bridge. On the face of it this could be beneficial by diverting an element of traffic away from Junction 11 and Hennef Way, but the diverted traffic will inevitably still use the Tesco roundabout, so there will be no reduction in traffic volumes for Banbury town as this option will not relieve the North Bar / Horse Fair / South Bar corridor, which is both key to movement around the town centre and also the other Air

Quality Action Zone. To this end the Society continues to support and promote the scheme that has been around for a good number of years to provided a new route across the river valley to the south of town in order to allow traffic from the west and south to access the M40 and destinations to the east without having to pass through the centre of the town ie. the South-to-East Link Road.

This we are told is presently 'too difficult and too expensive', so conditions in Banbury will continue to worsen as the population grows !

There have been an increasing number of planning applications during the past year proposing the conversion of

accommodation above shops in the commercial core of town into residential use. The Society welcomes these as a means of 're-populating' the town centre, but when necessary we comment that proper provision must be made for refuse and cycle storage in order to ensure that there is not an unsightly 'rash' of refuse bins and other items left in public view in the shopping streets of the town. At the same time the Society, and the Town Council, are concerned at the trend towards conversions into H.M.O.s (Houses in multiple occupation).

Similarly the Society has made representations to both Cherwell and Oxfordshire regarding the proliferation of advertising banners on pedestrian guard railing and of developers 'direction' signs on OCC street furniture such as lighting columns and traffic signs. Such items reduce visibility and distract both motorists and pedestrians - as well as making the town look like a 'jumble sale'.

The review of the Banbury Conservation Area was completed in 2018 and thanks to the efforts of a member of the Society the inclusion of the historic part of

Neithrop has been achieved. Also members of the Society assisted the Council's Conservation Team by undertaking 'leg-work' on a street-by-street basis to update records and gather essential information.

We understand that the necessary notifications to affected residents / owners are in hand and these are expected to be completed in the next few weeks and will also be publicised in The Link.

When appropriate the Society's has been represented at meetings of the Planning Committee and, when there has been an issue of significant importance, they have addressed the Committee on the relevant aspects.

The Society is represented at the quarterly meetings of the Town Centre by Robert Richwood, who reports that the last two meetings in 2018 were poorly attended by the other stakeholders, or even cancelled, but the most recent (in January 2019) was well attended and productive.

This meeting received a very useful Introductory talk by Iain Nicholson, the Interim manager of the Business Improvement District, the permanent manager having resigned in October (after 6 months). Iain will be in charge till a new permanent manager can be recruited.

The matters of interest raised by the Society

were received in a very positive manner :-

a) Society members will have observed that Oxfordshire C C is re-Instating block paving where unsightly patches of black tarmac had been laid either by utilities or where tree roots had caused an uneven walking surface. A 'soft flexi compound' is being laid to accommodate growth, but if there are any tarmac areas remaining, this is due to lack of information as to the locations and The Town Council is to identify any overlooked tarmac areas and advise O.C.C.

b) Ian Nicholson said that signage for shops and other facilities around the "Old Town"; is near the top of his "to do" list. All agreed that this was a sound idea subject to any signage complying with conservation area requirements. No short term action likely but given the general support is very likely to materialize this year.

c) the Society has drawn attention to the lack of bus timetable information, particularly for non-residents. The discussion revealed some lack of clarity as to which bus routes/services were actually authorised to use the bus station!

O C C were asked if they had responsibility for public transport Info throughout the County, but initially they said this was only for services supported by the County Council. Some further Investigation by the Town Council is needed.


